Douglas County Adult Detention & Law Enforcement Center

Officers and technicians from the Douglas County, GA Jail recently visited the Black Creek Irondale Campus for a factory test/demonstration. Black Creek is a subcontractor to [Turner Construction](#) and is providing the security system for the new 1,500 bed design/build facility, which is scheduled for completion this Fall.

Full Video Visitation Systems - including 8 Quad Pods, a family visitation unit and over 100 ruggedized inmate visitation stations are included in the build of this cutting-edge detention facility. In addition, CCTV, card access, duress, intercom, paging, elevator and utility control will be fully integrated into the facility's network of 32" LCD Super Display Touchscreen monitors.

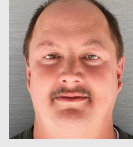
RFID Scanning Features added to the Black Creek Line of Personal Detention Assistants (PDA's)

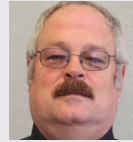

Black Creek Employee Awarded CCO/JUV Certification

This February, during the ACA Winter Conference, Sharon Lewis took (and passed) the American Correctional Association Officer Certification Exam. Lewis, Creative Director & Web Master at Black Creek, studied for and took the exam in an effort to learn more about the Corrections Industry from the perspective of an officer. Members of the ACA, who advocate continuing education and broader public knowledge of the corrections industry, graciously allowed her to sit for the exam.



I imagine having the ability to network with other county facilities' jail management systems. You could save time by pulling information about previously incarcerated inmates from neighboring jails. You could also more proactively classify an inmate based on data from a previous booking at another facility. This is the impetus behind the creation of Black Creek's SPIDEX Module.

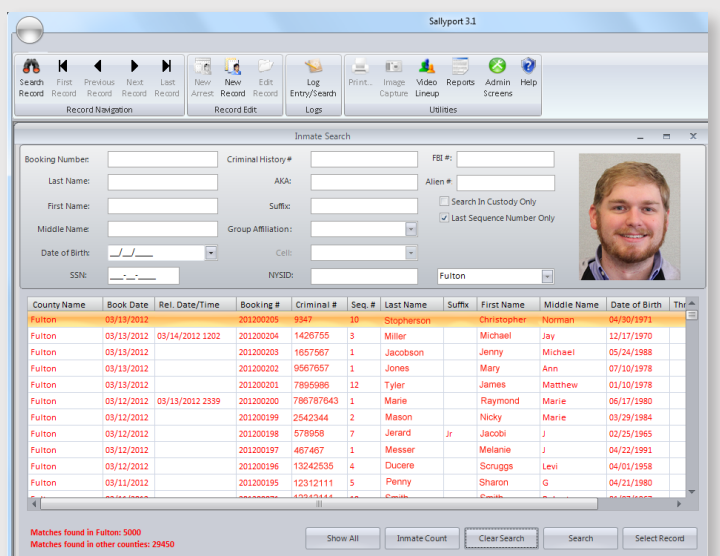
SPIDEX, or SallyPort® Inmate Data Exchange, is designed to work with the SallyPort® Jail Management System and is currently in use at facilities in New York. The module allows for access to inmate records across the facilities within the same network. So if one jail in New York is receiving a board-in from another facility, the inmate file – along with classification information – can be accessed and associated with the new location. In accordance with HIPAA laws, the medical information and suicide screening is not part of the information transfer.

The module has proven useful in many operational situations, including acting as a search tool for outside agencies seeking a person of interest. The facilities using SPIDEX are able to more quickly point the agency to the correct county facility. SPIDEX also pulls information on previously released individuals – which enables facilities to work with more information at booking.

The SPIDEX module creates an information bridge through technology and fosters a more seamless network among correctional facilities. Ultimately, SPIDEX provides the information officers need to conduct safer, more expedient intake of inmates – both board-in's and new arrests.

“With SPIDEX, we can quickly access information on board-in's and board-out's without having to conduct a whole booking. We use it get information regarding classification that we wouldn't have otherwise had. It is very useful and easy to use.”
